## NOTICE OF STANDARD OPERATING PROCEDURES

in compliance with “Perintah Kawalan Pergerakan Bersyarat” / Conditional Movement Control Order,  
9 November – 6 December 2020

---

1. The Government has extended the implementation of the **Conditional Movement Control Order** (the “Order”) that will take effect from **9 November to 6 December 2020** (“Period”). The Order allows Jing An Lin (“JAL”) to continue **operations**, subject to Standard Operating Procedures (“SOP”) established by Majlis Keselamatan Negara (“MKN”).
2. Physical distancing rules, temperature screenings, use of face masks, and contact information of visitors and/or agents via the MySejahtera app (or manual registration of contact details) shall be strictly adhered to. Persons with temperature **exceeding 37.5°C** will not be permitted entry and are advised to seek immediate medical consultation.
3. In similar fashion, **bereaved family members/guests/customers/agents/service providers** attending to interments or placements are to abide by this Notice and in particular:
  - Temperature screening and contact information to be taken of all accompanying persons and submitted to JAL for retention for a period prescribed by MKN’s SOP. Any persons who record a body temperature **exceeding 37.5°C**, will not be permitted entry and will be advised to seek immediate medical consultation.
  - Families to be advised to keep attendees reduced / limited to avoid group clustering that makes it difficult for physical distancing rules to be observed.
  - Services during interments and placements are to be kept as simple and as brief as possible.
  - Attendees should follow recommended safe practices such as physical distancing, stringent hand hygiene, and use of face masks.
  - Those who are unwell and are at-risk (e.g., elderly, young children, immune-compromised) should be advised to remain at home.
  - Only minimal or nominal attendance / services will be provided at the Multi-Purpose Hall. Visitors and guests are to adhere to the seating and table arrangements which are set apart by minimum 2m; and/or limited to 2 pax per table.

This Notice is based on current available information and may be revised as new information becomes available or conditions are changed. JAL will prescribe and comply with any other restrictions or prohibitions that may be imposed by the Government at any time, to take effect immediately, without notice. We wish to apologize in advance for any inconveniences you may experience during this period of operational restrictions and request your kind understanding and cooperation.
